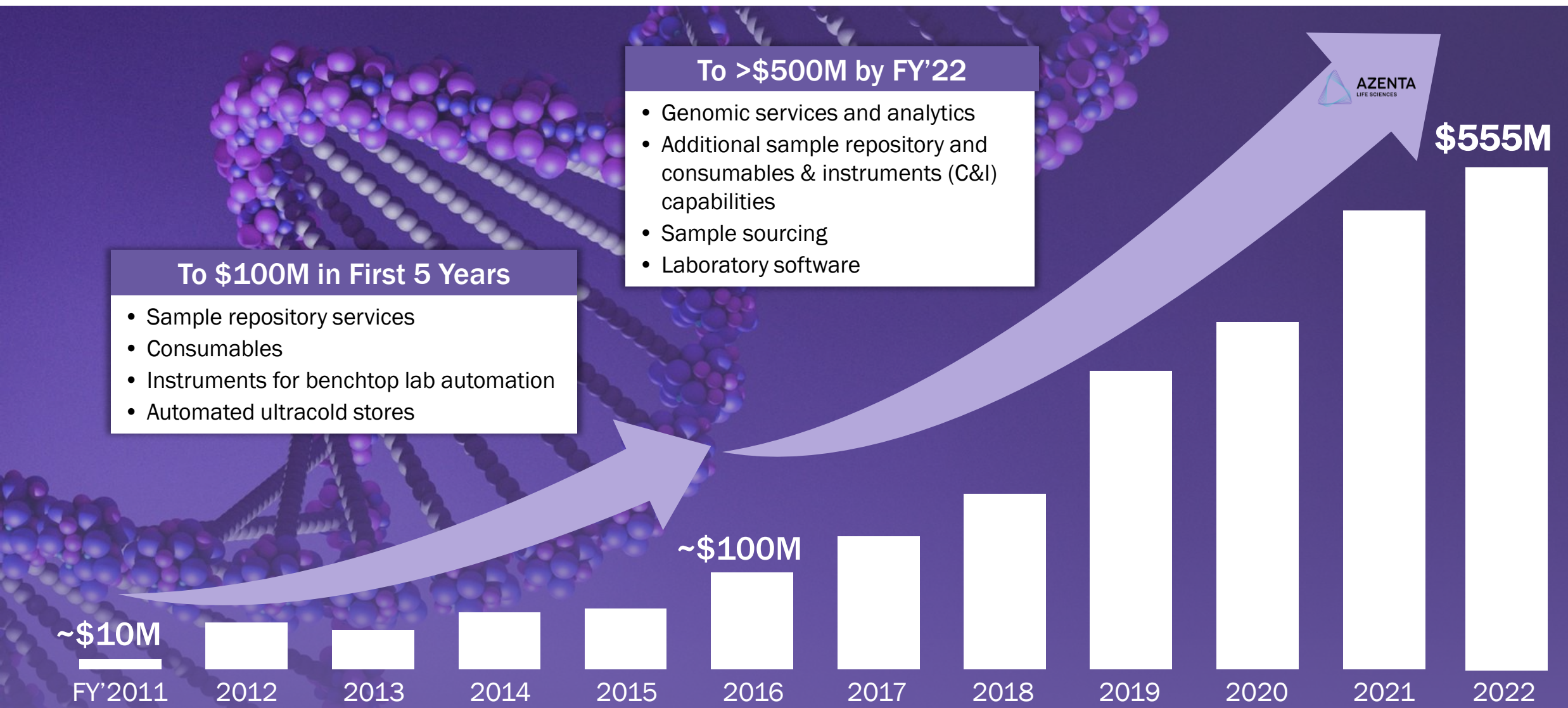

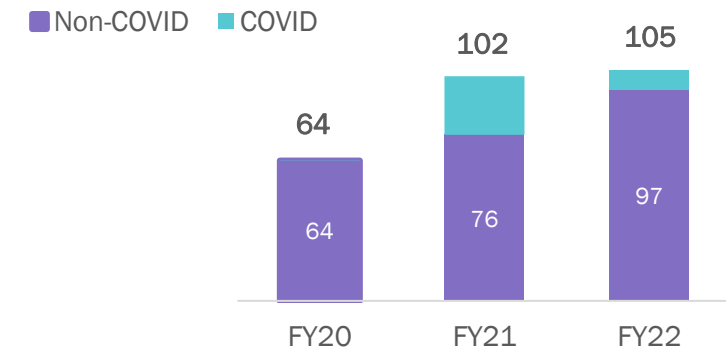

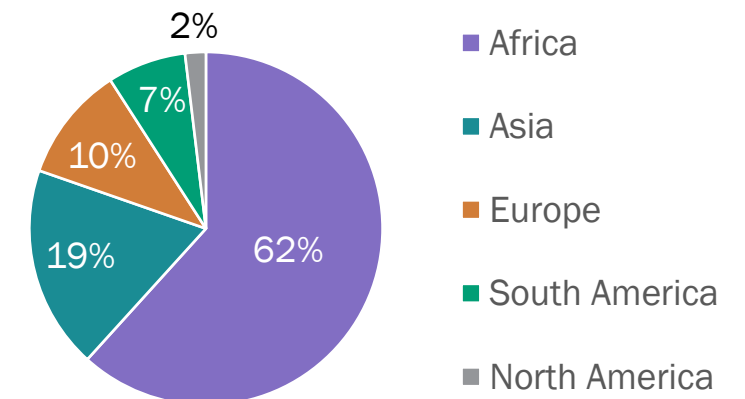

FY2022 REVENUE BY GEOGRAPHY



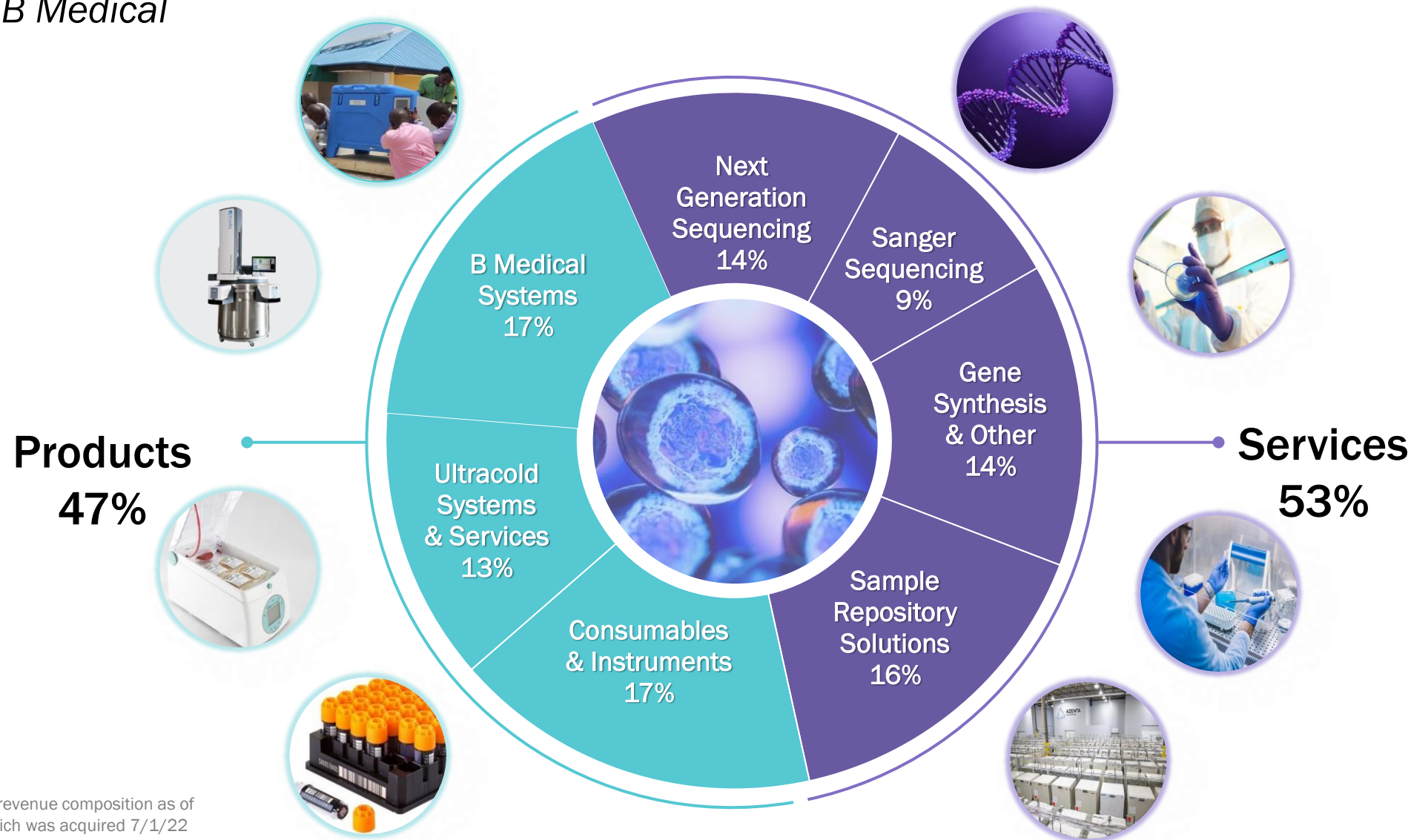

Pro Forma B Medical



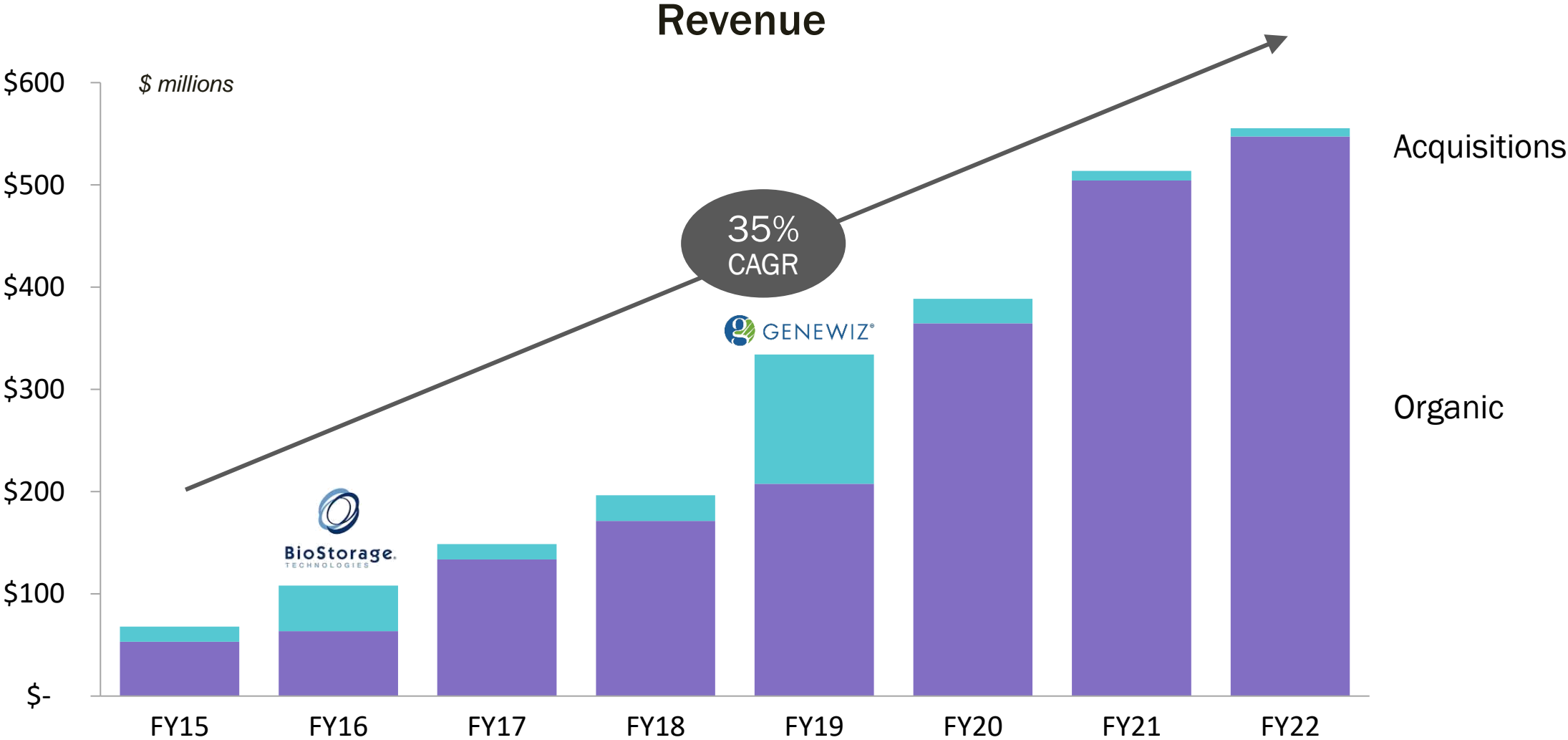

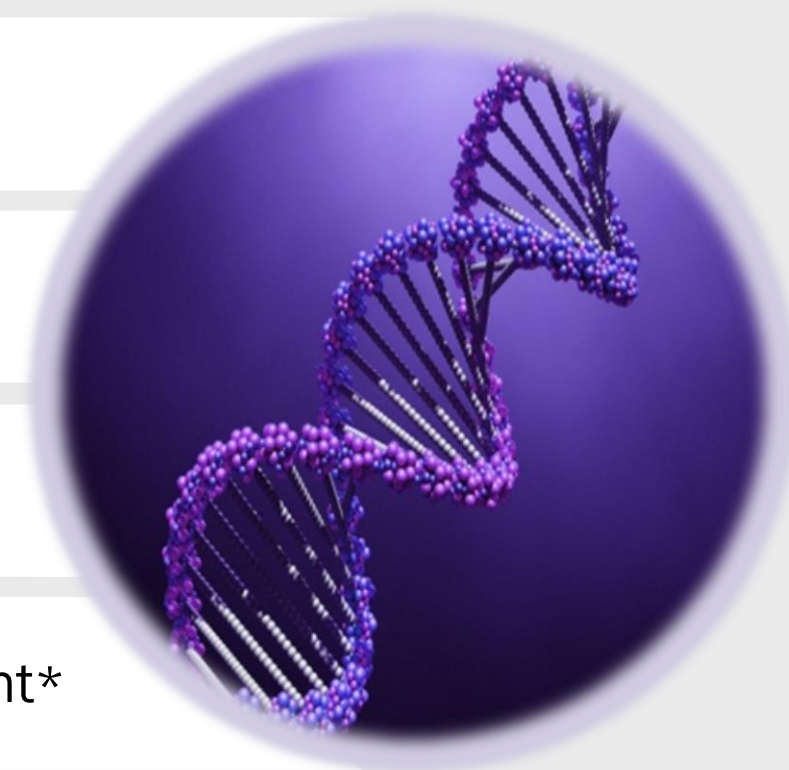
